# **Sanctions Policy**

BHS Qualifications (BHSQ) is committed to ensuring that learners taking its qualifications have the best possible learning experience, and have appropriate opportunities to achieve at the highest possible level.

In order to do this, BHSQ has in place a centre and qualifications approval process to confirm that a centre wishing to deliver its qualifications has in place the appropriate resources, systems and processes.

This process culminates in the completion of a signed, enforceable agreement in which the centre declares that it will comply with the requirements of BHSQ. To support high quality delivery in its centres, BHSQ has a series of policies and procedures to which centres must adhere.

Should any centre found to be in breach of the declarations they have made, or in breach of any of BHSQ's policies and procedures, then sanctions may be imposed.

BHSQ has a tariff of sanctions for dealing with those approved centres whose management, assessment and quality assurance systems fail to meet the centre approval requirements. The tariff is designed to ensure:

- A transparent, fair and consistent response when specific shortcomings are found.
- Public confidence in the quality assurance and control arrangements underpinning qualifications.

BHSQ may withdraw centre approval for reasons not directly related to the quality of assessment, such as a failure to meet BHSQ's commercial terms of business. The tariff will be reviewed and updated as necessary in the light of operational experience.

The centre's appointed external quality assurer (EQA) and/or the BHSQ Manager will agree sanctions, each breach will be assessed on a case-by-case basis. Sanctions will be imposed at a level commensurate with the breach.

In instances where malpractice has been proven to have occurred, sanctions will always be imposed.

Sanctions may be imposed if:

- A centre is in breach of its centre and/or qualification approval.
- A centre is in breach of any BHSQ policies or procedures.
- A centre is found guilty of malpractice and/or maladministration.

#### Sanctions might include:

- Withdrawal of centre and/or qualification approval.
- Conditions to centre and/or qualification approval.
- Suspension of centre approval status for all BHSQ qualifications.
- Suspension of approval to offer a specific BHSQ qualification.
- An increased number of external quality assurance visits, quality advisory visits or centre visits by appointed BHSQ personnel at the cost of the centre.
- Training for the centre workforce.
- Disallowing all or part of the learner's internal assessment evidence.
- Disallowing all or part of the learner's external assessment evidence.
- Not issuing the learner's certificate(s).
- Not accepting any further registrations for the learner.
- Other appropriate measures to prevent recurrence of malpractice and/or maladministration.

### The tariff of sanctions

The tariff links five levels of transgression against the centre approval requirements with a required sanction. These are set out below and represent the minimum response required to a particular shortcoming or problem.
